2011 UNIFIED CARRIER REGISTRATION

As of October 15, 2010, carriers, brokers, freight forwarders, and leasing companies may file for their 2011 Unified Carrier Registration.

It was announced that the fees for this upcoming year will remain the same from 2010.

Keep in mind that practically everyone in the transportation industry must file UCR each year.

You are also required to file for UCR for every year that you have had an interstate DOT number, so be advised that you can still be fined for failure to comply with previous years' UCR filings.

In order to avoid fines for 2011, make sure you file this before December 31, 2010.

Fines for noncompliance range anywhere from \$300 for a first offense, up to possible jail time for repeat and vagrant offenders, depending on the state in which you are pulled over. Get your 2011 filed today to avoid any delay in driving!

Also, this is a good time to make sure your DOT information is up-to-date and correct. Remember that DOT numbers must be updated every two years and as changes occur.

Upcoming Deadlines

It's that time of year again! You must have your 3rd quarter reports postmarked by October 31st in order to avoid additional penalties and fees. Our fuel tax customers must have submitted their required information by October 12th to guarantee on-time processing.

 3rd Quarter for IFTA is due to your state with a postmark no later than October 31. Be sure to include your form of payment with your IFTA account in the memo of the check.

- 3rd Quarter for Kentucky's KYU is due to Frankfort, KY postmarked no later than October 31st. Include payment and KYU# on check with form.
- 3rd Quarter for NM Weight Distance Tax is due to Santa Fe, NM with a postmark no later than April 30. Include payment with form.
- 3rd Quarter New York Hut is due to Albany, NY

post marked by October 31st. Don't forget to include your payment with the form.

 OR permit holders must submit their monthly reports with a post mark date of October 31st.

Also, year end deadlines are just around the corner! Remember, IFTA, NM WDT, and UCR must be renewed by December 31st to avoid penalties and interest. We are happy to offer these renewal services to our customers.

Most lawmakers, however, have refused to consider a gas tax increase, both because of its political peril and also for fear of hampering businesses and households during bad economic times.

Please be advised that the letter sent out to new entrants by the FMCSA to validate a DOT appointment contains an incorrect phone number.

DOT has changed contractors. However, several letters were sent out to carriers listing the old phone number, which when called merely rings and rings.

The correct phone number is 1-877-905-8016. Please call this number to set up your DOT appointment.

New letters should have been mailed out to new entrants, but in case you did not receive your letter, please keep in mind that your initial new entrant inspection is required in order for your DOT number to remain in service. For questions, please contact us at 405.701.4173.

This spending bill would be brainstorming ways to raise **Registrant DOT # Now Obsolete**

The Federal Motor Carrier Safety Administration announced that beginning on September I, 2011, Registrant DOT numbers will no longer be issued.

The FMCSA is doing away with these numbers due to inappropriate use by carriers.

FMCSA said in the notice it posted in the Federal Register that the purpose of the registrant DOT number when it was first introduced in 1999 was to track ownership of commercial motor vehicles in the Motor Carrier Management Information System (MCMIS).

It does not authorize a non-motor carrier to operate in interstate commerce, and it should not have any safety events assigned to it.

However, there have been

numerous instances where carriers have provided a registrant DOT number to a DOT officer during an inspection or crash investigation, instead of the motor carrier company to which the driver is leased to.

This practice has caused confusion with safety ratings and many carriers have incorrect ratings due to this.

FMCSA said it conducted an analysis in 2009 and found that over 35,500 (18%) of the more than 200,000 registrant-only records in MCMIS contained crash and inspection activity that should have been recorded on the lessee's motor carrier record.

Therefore, registrant DOT numbers will no longer be issued and those already issued will become dormant starting September 1, 2011.

Text Ban Ruling

On September 21, 2010 the FMCSA released its final ruling on Limiting the Use of Wireless Communication Devices.

"The FMCSA prohibits texting by commercial motor vehicle drivers while operating in interstate commerce and imposes sanctions, including civil penalties and disqualifications from operating CMVs in interstate commerce, for drivers who fail to comply with this ruling."

In addition, motor carriers are prohibited from allowing or requiring drivers to

The 2010 Distracted Driving Summit was held this year on September 21st in Washington D.C. United States Secretary of Transportation Ray LaHood hosted this year's event again and encouraged America's youth to be proactive in the fight against distracted driving.

Secretary LaHood convened leading transportation officials, safety advocates, law enforcement, industry representatives, researchers and victims affected by distraction-related crashes to address challenges and identify opportunities for national anti-distracted driving efforts.

Last year, distraction-related crashes killed at least 5,500 people and injured more than 450,000 others. But with the help of events such as the Distracted Driving Summit, hopefully states will continue to advance the precautions and laws set forth to prevent these unnecessary accidents.
