Today's cell phones are not just for phone calls and messages alone. With the popularity of Smartphones we now have access to our email, the Internet, GPS navigation, and many other tools. The trucking industry has fully embraced this technology for use in their business operations.

According to a recent survey by uShip owner-operators have increased the amount of usage on their phones for business purposes by 57% from the previous year. 37% use their phones to book loads, and 35% use them to bid on loads.

Many are now traveling without a laptop and just the use of their phone to monitor weather, gas prices, traffic, and stay connected socially with friends and family. In fact when asked in a recent poll 20% of truckers say they would give up their CB radios, 16% would give up their spouses and 8% would give up their pets before they would be without a cell phone.

- Oregon permit holders must file their reports by the last day of each

month.

In 1929, at the age of 32, Lillie Elizabeth Drennan was the first women to get a CDL license. After divorcing, she became the sole owner of the Drennan Truck Line. She ran this business for 24 years and as a driver never had an accident. She set the pathway for other women who were interested in following in her footsteps.

In 1977, Lee Way Motor Freight based in Oklahoma City, introduced women co-drivers to their compa-

ny due to the Equal Employment Opportunity Commission's requirement. This caused guite an uproar, with a group formed to protest the Despite policy. the naysayer's protests, Lee Way Motor continued to make women a part of their business.

There are approximately 1,319,000 women employed in the trucking industry with about 166,000 (4.9%) holding the title of driver. There

are 9056 women owned trucking companies in North America, with an astounding 98% being in the US and 0% in Canada. With the number of women in the industry increasing every year there has been a greater need to accommodate these women. There are great organizations such as; the National and International Women's Trucking Association and Women in Trucking Association.

FMCSA's Improvements to CSA

There have been some improvements to the Compliance Safety Accountability (CSA) program in order to identify and take care of companies with compliance issues. This is to help reduce the amount of tragedies caused by unsafe truck and bus companies that go unnoticed. "Good data plays a key role in keeping our nation's roads safe," said Transportation Secretary Ray LaHood.

The changes that have been made will take affect in December 2012. Some of the changes that will occur are:

- Clarify the definition of passenger carrier companies
- To guarantee citations are consistent with current speedometer

regulations by removing I to 5 mph speeding violations

Making sure all recorded violations precisely replicate the inspection type

"CSA is raising the bar for truck and bus safety. Our preliminary data shows that fatalities involving commercial vehicles dropped 4.7 percent last year compared to 2010," said FMCSA Administrator Ferro. "Still, on average, nearly 4,000 people die in large truck and bus crashes each year. That is why we are implementing these important changes to make CSA even more effective."

Diesel Prices Continue to Increase

The U.S. Department of Energy reported on August 28, 2012 diesel fuel rose 6.3 cents to \$4.089 a gallon. It has been reported that diesel has increased 26.9 cents more than this time last year with 44.1 cents just in the last 2 months. However, oil prices have decreased for the past few weeks, oil companies are not sure what the impact of the tropical storm lsaac will have on the industry.



National Registry of Certified Medical Examiners

DOT has set forth yet another resource to further help make the roadways safer. As of May 21 the National Registry of Certified Medical Examiners system has gone live. This new system is a rule announced by the FMCSA to improve driver medical standards.

It requires all medical examiners that perform exams on drivers be trained, tested, and certified. Once they are certified they are placed on the National Registry so that drivers can locate an examiner in their area.

It is important that the drivers locate and use the registry to make sure that the ME that is evaluating them is meeting the standards of the National Registry. With this in place it is proposed to reduce the risk of commercial vehicle-related crashes, injuries and fatalities.

Tire and Safety Regulations

The FMCSA has issued a warning about the tire safety for motorcoaches. They want drivers to be more aware of the maximum tire load capacity, speed rating, and the overall safety margin when carrying maximum passenger and luggage loads. Raised awareness of these issues could save lives. It is important for the operators of these motorcoaches to put policies and procedures in place to monitor the load weight and tire pressure to confirm they are within the requirements.

There are other things to consider as well, such as the elements as to which you are traveling through. With drought and extreme heat across the US, it can cause tires to fail and cause serious issues. If the FMCSA concludes that there is a violation of tire loading restrictions, the carrier and their vehicles and be put out of out-ofservice.


