Just in the U.S. only, 115,000 truck driving jobs will become available by the end of 2016. However, companies are having a hard time getting young drivers willing to drive long distances. There is a worry that there will be a shortage of drivers that will cause longer wait time for shipments, higher cost to move shipments, and with less availability the cost of the goods would increase.

It is estimated that in America only about 10% of the drivers needed, will be trained to drive a truck.

The other issue that many companies run into is that the drivers that are applying for the positions are older men that will probably not be able to drive for years to come.

Some companies are trying to entice young drivers by offering higher wages. Other companies are trying to shorten the routes to help get people home sooner, while others offer paying for their training costs once they complete the course.

career. Being on the road for weeks at a time is hard, and not being home with their family for those long periods of time is even harder.

But many have to weigh the pros and cons of the job. Depending on what company you work for, you can make an honest living with a stable job. All the while getting to travel and see things you might otherwise not get to see in your lifetime.

Safe and Efficient Transportation Act

In February there was a new act introduced called the Safe and Efficient Transportation Act of 2013. This would allow an increase of weight of Interstate trucks from 80,000 to 97,000. While this will help increase the amount of tonnage that can be shipped at one time, saving time and money, there are major concerns with safety on the nation's roadways.

The Safe Highways and Infrastructure Preservation Act, or SHIPA, is trying to make sure that the changes do not take place. They believe that safety should come before profit.

Joan Claybrook from the Truck Safety Coalition states that "Families are paying with their lives and with their wallets." A poll showed that 68% of Americans opposed the weight increase. 88% do not want to pay higher taxes to have to repair damage to the highways.

Claybrook states that she is certain that SHIPA will pass this time around.

First Observer

Some truck drivers are being trained to do more than just drive a truck. There was a program started in 2004 by the American Trucking Associations that trained drivers to keep a look out for suspicious activity that could be terrorist related. The program was renamed to First Observer in 2009 with help from the Teamsters Union and the Owner-Operator Independent Drivers Association.

It is said that the Transportation Security Administration has offered a deal to Triumph Enterprises Inc. to take over the First Observers Program. However, the specifics have not been made public as of yet. This program gives truck drivers a chance to report

crimes first hand that would prompt FBI to get involved. Or if the driver saw something that just didn't make sense. For example, if there was a tanker full of gasoline in an area where there would not be delivery locations

You can go to firstobserver.com to train in different areas on how to spot anything that may need to be reported. The basic program helps identify national security issues and to help drivers stay aware of things going on around them as they drive.

Mexico Driver Pilot Program

Recently an appeal that was filed by a group of U.S. truck drivers, challenging the federal pilot program that would permit Mexican truck drivers to deliver freight in the U.S. was lost.

The dispute was that a CDL from Mexico was not valid in the U.S. However, it was decided by Congress to be valid.

There was a question whether or not the medical standard for Mexican drivers is up to code. Also, if the decals that are required to be on display to show compliance would be required for US operation.

Drivers in the U.S. felt that it is not reasonable to ask them to make sure that they comply with all the requirements necessary to stay legal to run while making exceptions to the rule for drivers from Mexico.

Truck Sales Increase

New truck sales for the month of April reached its highest in 15 months, with 23,300 sold. April's total is 36.2% higher than the 17,105 orders that were placed in April of 2012. This also marks consecutive seventh month that sales have reached more than 20,000 trucks for the month.

With the increase in sales, production is slated to increase as well. It is projected manufacturers around 55,000 trucks during

the first quarter. However, manufacturers are looking to production increase around 66,000 during the second quarter, 69,000 in the third, and 72,000 in the fourth quarter.

It is hopeful that with the increase sales and production, that those that had lost their jobs in the industry of building trucks on the production line will soon find job openings again.

Diesel Prices Continue Decline
